4. New Business

4.1 Draft Housing Needs Assessment

Odete Pinho, EcoPlan, provided the Task Force with a presentation on the Draft Housing Needs Assessment. The presentation included information on the report approach and summarized the key findings regarding population and demographics, housing overview, economic wellbeing, core housing need and areas of local need.

Rod Ferguson entered the meeting at 4:51 p.m.

Discussion ensued and the Task Force Members provided the following suggestions to be included for consideration in the final Housing Needs Assessment report

- Separate extreme core housing need data from core housing need.
- Break data down by suite sizes and age demographic to determine what the actual need is.
- Include statistic for current subsidized rental units in the community, percentage of subsidized or extreme core rental units in community.
- Utilize City's electrical utility billing to run yearly cross reference on names leaving/arriving and address shifts to capture data on departing residents.
- Include data on how many rental units need to be built per year to reach 3% vacancy rate goal.
- Include in the core housing need data information about accommodations specifically adapted to different accessibility needs.
- Include more statistics on types of housing being built in City.
- Include income vs. affordability data.
- Executive summary precedes the assumptions and data limitations, put at forefront so anyone reading knows data is predicated.

4.2 <u>CMHC Housing Accelerator Fund (HAF)</u>

Gordon Easton, Easton Planning and Development, presented the Canadian Mortgage Housing Corporation Housing Accelerator Fund Application (HAF). The presentation reviewed the program highlights, four key drivers, the funding methodology, recent building permit history, future growth/need, and nine action plan components.

The Task Force was informed that the next step is to flush out the application to provide realistic projections of number of units without HAF and number of units with HAF and how they would get allocated before presenting to Council for endorsement in August.

Discussion ensued and the Task Force Members provided the following suggestions on

- Have a community development lens with the residential team to make it more robust.
- Increase accessibility for new comers to relocate with more ease may be an approach to set our community apart from others of similar demographic.
- Highlight working together with other surrounding communities to strengthen application.
- Possibility to do pre-approved plans for duplex, triplex and fourplex along the expected Provincial rezoning changes allowing up to 4 units per lot.
- Tie Housing Accelerator Fund (HAF) initiatives to climate action and resiliency
- Task Force to consider if there is more to be added into the action plan.
