2019-2023 Five Year Financial Plan – Key Dates

Electric Utility Services Bylaw No. 2017-44

Council gave third reading as amended to "Electric Utility Services Bylaw No. 2017-44", a bylaw that regulates the service area, provisions of service and electrical safety standards.

Greyhound Property – 303, 307, 313, 317 & 319 Ellis Street Building Demolition & Parking Lot Construction

As the long term vision for use and redevelopment of the Greyhound property takes place over the coming years, Council supported the demolition and construction of a parking lot containing 55 parking stalls at 303, 307, 313, 317 & 319 Ellis Street. The parking lot will accommodate alternative forms of transportation such as electrical vehicles and bicycles with bike lockers and bike racks.
