

## March 3, 2020 - Council Meeting Highlights

### **Emergency Support Services/ALERT**

Alida Erickson, Emergency Support Services and Deborah McBride, ALERT, promoted emergency preparedness for residents and pets.

### **Cantex Property Development Opposition to Ellis Creek Master Plan**

Neal Davies, Vice President, and Drew Nagy, Property Manager, Cantex Group of Companies provided Council with a presentation on future Cantex property development and opposition to the proposed Ellis Creek Master Plan.

### **Cantex Development Plan**

Frank Conci, President, Penticton Industrial Development Association, spoke in support of the Cantex future development plans.

### **Removal of Property from the City of Penticton Heritage Registry**

Council referred the request to remove the property at 452 Lakeshore Drive from the City of Penticton Heritage Registry to the Heritage and Museum Advisory Committee.

### **Joint Grant with RDOS – Indigenous Cultural Safety and Cultural Humility Training**

Council supported a joint grant application with the RDOS to the UBCM Indigenous Cultural Safety and Cultural Humility Training Program and that the RDOS apply for, receive and manage the grant funding on the City of Penticton's behalf.

### **In-Year Grant Requests**

Council approved a \$4,000 in-kind grant to Beacons Furry FUNdation Society and denied the grant request to Conseil Jeunesse Francophone de la C.-B.

### **2021 Grant Request – Elvis Festival Society**

Council approved a \$15,000 in-kind grant to the Penticton Elvis Festival Society to be included on the 2021 budget to support the venue costs of the SOEC for finale performances.

### **Council Procedure Amendment Bylaw No. 2020-04**

Council adopted "Council Procedure Amendment Bylaw No. 2020-04", a bylaw that allows for electronic participation at Council Committee meetings.

### **Temporary Use Permit PL2019-8678 for 'rock crushing' re 3200 Evergreen Drive**

Council approved "Temporary Use Permit PL2019-8678", a permit to allow for the operation of a "rock crusher" located at 3200 Evergreen Drive for a three (3) month period subject to the following conditions:

- No processed materials are to leave the site;
- The rock crusher is only permitted to be operated between the hours of 8 a.m. and 4 p.m. and only from Monday to Friday;
- Appropriate dust control measures are to be taken at all times;
- A sound barrier (earth berm) along the existing gully must be created to reduce noise around the crusher.

**Manufacturing Brewery Lounge and Special Event Area Endorsement for Neighbourhood Brewing Company Inc. re 187 Westminster Avenue West**

Council directed staff to commence public notification of the proposed Brewery Lounge and Special Event Area endorsement application from Neighbourhood Brewing Company Inc. located at 187 Westminster Avenue West with restrictions of exterior patio service hours and no amplified music past 11 p.m. Council also directed staff to report back on the results of the public consultation at the April 7, 2020 Council meeting.
