

City to pursue a grant to help address daycare shortage

A grant from the Childcare BC New Spaces Fund could help alleviate Penticton's childcare shortage and provide a solution for a few of the City's aging buildings. At the Council meeting on November 5, staff introduced a plan to work with a partner and apply for funding to replace the Edmonton Avenue Centre building in Kiwanis Park with a new, expanded childcare facility.

"There are waitlists for most daycares in Penticton and this lack of childcare is often cited as a deterrent to families looking to relocate to the city," says Ben Johnson, Acting Director of Development Services. "If successful, this grant could provide up to \$3 million towards a new childcare facility with space for more children."

The City issued an Expression of Interest to identify partners following the Council meeting. "The City does not provide daycare services, but we can certainly support efforts to meet this important need," says Johnson. "By having a partner, we can leverage



their knowledge of the childcare needs in the community and their expertise to design and operate the service."

In addition to the Edmonton Avenue Centre building, Kiwanis Park is also home to the Little Triumphs Daycare building and a storage building used by the Safety Village. All three buildings are City-owned and were rated in poor condition in the 2013 Facilities Master Plan. The City intends to work closely with all of the groups currently providing services in Kiwanis Park to develop a proposal that addresses their interests and the condition of the buildings.

Volunteers help honour passed loved ones

In conjunction with Adopt-a-Park, a volunteer special project program that invites individuals, organizations or service groups to register and perform light-duty maintenance tasks within City-owned parks and green spaces, the City of Penticton Parks Department is partnering with Schoenne Homes to restore and repair monuments and headstones at the Lakeview Cemetery.

"We were pleased to learn that Schoenne Homes had an interest in participating in the Adopt-a-Park program," said Parks Supervisor, Todd Whyte. "The City completed a cemetery Masterplan in 2013 and the volunteer work that Schoenne Homes is proposing aligns perfectly with the restoration and repairs outlined in that masterplan."

Through the partnership, Schoenne Homes will coordinate volunteers to Lakeview Cemetery to restore and clean older and untidy headstones. The goal is to help with beautification of the cemetery as well as show respect to those in the community who have passed away. Many headstones have moss and other dirt and grime that could benefit from a thorough restoration.



"We think this a great opportunity to help out in the community and show respect to citizens that the community has lost," says Chris Schoenne of Schoenne Homes Inc. "We are looking forward to taking on this project and would like to thank the City of Penticton for accommodating our proposal."

Sidewalks should be clear of snow and ice

The City is reminding residents who own or occupy properties in Penticton to clear snow and ice from sidewalks bordering their properties. The Good Neighbour Bylaw requires all sidewalks adjoining private properties to be cleared of snow and ice before 11am following a weather event.

"We all have a role to play in removing snow and ice. City sidewalks bordering public property are cleared by crews in accordance with the City's snow clearing priorities while sidewalks bordering private property are the responsibility of the adjacent owner or occupant", said Public Works Manager, Len Robson. "If the sidewalk bordering the property you own or occupy is covered in snow or ice, please see that it is cleared."
